

Maine Farms Scavenger Hunt Terms of Service

NO PURCHASE NECESSARY. To enter, submit a valid email address, first and last name and phone number via the online form, along with answering all of the questions on the survey (“Entry”). Incomplete Entries will be disqualified. All Entries shall become the property of Maine Farmland Trust, Inc. (“MFT”). MFT is not responsible for lost, misdirected or delayed Entries. Entries received by telephone, fax, courier or personal delivery will not be accepted.

The Maine Farms Scavenger Hunt (the “Game”) begins June 1, 2021, and ends September 15, 2021.

Individuals and/or families are invited to participate.

Participants must complete the Game no later than the end date of September 15, 2021 in order to be eligible for prizes. Following that date, prizes will be awarded in accordance with the points achieved by Participants. Points will be rounded down to the nearest Prize Level. Participants are eligible to receive only one (1) Prize Level.

Prizes are not redeemable in cash.

Decisions of the Game judges are final – no substitutions will be available.
